Background

In January 2015, Albany County, New York, released a regulation to ban seven potentially harmful chemicals from children's products and children's apparel. This received a lot of attention at the time as it circumnavigated an already crowded landscape of state and federal regulations. Several other New York counties followed suit and passed their own legislation shortly after. Albany faced a lawsuit from the Safe to Play Coalition not long after the law was passed alleging two current acts preempt the county measure.

Definitions

- Children's apparel means any item of clothing that consists of fabric or related material intended or promoted for use in children's clothing.
- Children's product means any product primarily intended for, made for, or marketed for use by children. Children¹s product does not mean batteries, consumer electronics or electronic components, paper products, or a drug, biologic, medical device, food, or food additive regulated by the US Food and Drug Administration.

How To Comply

- · Know the chemical makeup of your products.
- Supply chain management Control your suppliers and make sure that they are not changing subcontractors without your permission.
- Control your manufacturing process Minimize the potential for contaminants.
- Testing Perform testing to ensure that your products are in compliance with the regulations.
